

WARRANTY TERMS

Warranty terms

Coverage and area:

The statutory warranty applies to all products.

The warranty conditions below apply to Mmtc Benelux B.V. products under the brands:

Mmtc Benelux, Axso, Studio Tab and all other private labels sold in the EU (hereafter: "private label products" or "products") and for which a product warranty has explicitly been issued.

Warranty period:

Within the warranty period, Mmtc Benelux B.V. guarantees that all products shall be free from material and manufacturing defects in case of normal use, provided the installation and maintenance instructions have been observed including normal storage (storage is taken to mean the condition whereby the product is not used for its intended purpose).

The warranty period commences on the date of purchase at the store by the original end user/purchaser. Deviating warranty periods may apply to some of the products and components. The applicable warranty period is stated on (the packaging of) the product.

Exclusions:

This warranty does not apply in event of: (a) wear, corrosion, discoloration and ageing as a result of normal use and normal storage; (b) damage caused by incorrect and/or improper maintenance; (c) product damage caused by external factors such as fire, water, vapour, liquids, ice, wrong application, falls, neglect, incorrect use (including use inconsistent with the instructions of Mmtc Benelux B.V.) or misuse; (d) consumables and replaceable components including **batteries (1-year warranty)**.

Invoking the warranty:

In case you would like to invoke this warranty, you need to notify the service desk of Mmtc Benelux about the defect within a reasonable amount of time after discovering the defect but at least prior to the expiry of the warranty period. Alternatively, you may contact the store. In order to invoke the warranty, the product (or defective part) as well as the original receipt should be presented at all times.

Liability restriction:

The liability of Mmtc Benelux B.V. is limited to the costs of repairs and/or replacement of the product under the warranty conditions. In case the product is replaced, the warranty date shall commence upon the acquisition of the original product. In any event, and as far as the law of the country in which the product has been purchased permits, Mmtc Benelux B.V. shall not be held liable for any loss of profit, consequential loss, indirect loss or any other special forms of loss.

This warranty shall not interfere with your statutory rights as a consumer and is exclusively valid and legally enforceable in the country in which the product has

been purchased.

Any service costs arising from the "Exclusions" clause shall be invoiced to the client.
